Project manager report: L. Wiens

- The project manager reported that construction of the 12 sand recovery stations (Intake 2013 program) was scheduled to start August 17, 2015 to be finished by September 15, 2015.
- It was also reported that recent surveys have shown that sites for eleven of the 12 sand recovery stations have been designated for construction on Crown Land. Mr. Wiens is taking whatever steps are necessary to resolve this matter.
- The rest of the project manager's reporting time was taken up by responding to ratepayers' questions relating to Hatzic Lake and Hatzic Slough water levels.
