# Appendix – 3

### 2018 Dyking Tax By-law #76 - May 14, 2018

The 2018 Dyking Tax By-law No. 76 submitted to the Ministry of Municipal Affairs and Housing in March was declined.

DAID's submission with a different tax rate for land and improvement values within a class and a different rate for Class 1 Residential and Class 9 Farm didn't meet Improvement District taxation legislation. Not being able to have a different tax rate/ratio for Class 9 Farm, when using assessed values will not provide the correction to the imbalance of farm land values that came to light during the taxation committee meetings.

After dialog with the Ministry, a new proposal with a combination of parcel tax, per acre tax and value tax for 2018 taxation was sent for their review. No response received at time of this meeting. By-law No. 76 & 77 will be presented at this meeting.
