Monthly update: December and January

For the most part a typical couple of months. Monitoring of the rain events and a pictorial developed over time of specific areas impacted by them and how this relates to PS operations. I am trying to put together a report on the Hatzic slough and surrounding properties as a starting point for discussions. As the beaver dam issue has focused attention on this area a number of issues impacting flow in and around the slough have been observed, I have kayaked this area over the last couple of months. I am sure this area is on the provinces radar and I am trying to stay current regarding the issues. I have been in contact with Hugh Davidson the area F director regarding issues in his area. More to come.

February Rain Event

- Prior to the weekend RB and I went for a drive around the valley witnessing a number of culverts and obstructions throughout the valley and Dewdney. Friday lake 1.4 river 1.1
- Saturday morning lake at 2.50 and still flowing out the flap gates. 3 pumps on with weather clearing.
- DS travelled up the valley and returned to the PS with RB and turned on the 2 old pumps.
- After the old pumps were turned off late Sunday afternoon it was clear we had a problem at the CPR culverts and the calls went out for help from the CPR crews. They arrived on site on Monday morning and were attempting to remove the highway barriers to access the site southeast of the culverts DS met them there in the morning before going to work and when they said they couldn't continue with the work I called

EAM and worked with both parties to insure the work was completed without anyone leaving the site, except for me, I went to work and returned in the afternoon and the crews were off site and area returned to its original condition. There was debris still in the culverts but they were flowing better the CPR equipment broke down and it was the best we were going to get. This dropped the lake about 300mm a day for the next few days without any more pumping. The following Saturday Ron and myself removed the remaining debris from the culverts. In retrospect I don't think it was the 150mm of rain that got us but the 12 degrees that came along with it.

PS Maintenance

- We have a laundry list of minor issues to deal with regarding to the pump station that don't become apparent until you go to use them for instance the greaser will require service overlooked in the summer when the pumps were serviced. Servicing of all the pumps are due this year.
- We have been working on a plan to enhance the security at the PS and Trustee Shelley has offered his
 expertise in this matter. Not to get into too much detail regarding the upgrades. They will involve
 surveillance and lighting in and around the facility. Prices are still being gathered for equipment and
 install but it will be very reasonable.

Communication

• While the chaos of Saturday was unfolding I got a call from Brent Hall and I returned his call and informed him where we were regarding the pumping which at that moment was changing from 3 pumps to 5. He said he would text me his post for my review, I responded later with an apologized for not getting to it, as you can imagine we were busy. I told him at the time that my expectation was that the lake would see a water level 3.1 to 3.2, and to my surprise I was correct, I also asked him to remove the CPR info from the text because I was afraid of upsetting someone before I needed them anticipating the potential for the culverts to be plugged.
