- Boom has been repaired.
- Zoom meeting with EMBC & FVRD regarding extreme weather events & flooding in 2021. It was noted that DAID does not have an Emergency Operations Center and this should be considered in the case of future events. It was also pointed out as to how close the water came up to entering the new pumpstation. Dave suggested that DAID may want to look into raising the pumpstation to protect the vital equipment inside.
- An application for Disaster Financial Assistance was sent to EMBC; we are waiting for their response, and continue to be in touch with FVRD Emergency Operations Centre.
- Discussed CP Culverts, and the fact that they are an issue with getting water to flow. FVRD is aware of these issues and CPR have also been made aware, but, at this point, there seems to be no resolution to the problem. At this point, Trustee Jim Loewen made a suggestion that DAID setup a committee and approach all levels of government and CPR to get some positive action on the ongoing issue, Ray Boucher also volunteered for the committee.
- The committee would also research the impact on the overall watershed from drainage coming from increased ground cover removal and property development from Mission City above Hatzic Lake.

Dewdney Bridge Project is still ongoing. Original plan/design had to be scrapped after major input from disgruntled local residents, so a new design is in progress and land acquisition for the bridge is also in progress.
